

COOKIES AND SIMILAR TECHNOLOGIES POLICY

ASOCIACIÓN HARAPAN PROJECT (hereinafter, the "Association") uses cookies and other technologies to ensure that all users (collectively, "Users") can enjoy the best possible experience when browsing this Website.

The information obtained through cookies will be collected and processed by ASOCIACIÓN HARAPAN PROJECT, with Tax Identification Number G-66446196, address at Calle Muntaner, 322, Pral 1ª, 08021, Barcelona, and e-mail address for these purposes harapanproject@gmail.com.

In order to offer a greater level of transparency, the Association provides detailed information on what cookies are, when and for what purpose it uses them in the provision of its services by means of this cookie policy (the "**Cookies Policy**"), which applies to any service provided through the Website.

What are cookies?

A cookie is a small text file that is placed on the User's device and that allows the storage of information related to the navigation performed.

Cookies allow this Website, among other things, to store and retain information about the browsing habits of Users or their devices, improving the User's experience and offering them a personalized use of the Website. Depending on the information contained in them and the use they are making of the devices, they can be used to recognize the User.

Types of cookies.

- Depending on their purpose, cookies may be technical, personalization, analytical or advertising cookies. Technical cookies and, in certain cases, personalization cookies, are exempt from the duty to inform the User.
- Depending on who sends them, manages them and processes the data obtained, cookies may be first-party or third-party cookies.
- Depending on the length of time they remain activated on the user's computer, they may be session or persistent.

Cookies used by the Website.

The Website uses its **own and third party cookies** for the following purposes:

- **Technical Cookies:** are those that allow the User to navigate through a web page, platform or application and the use of the different options or services that exist in it as, for example, control traffic and data communication, identify the session, access parts of restricted access, use security features during navigation, store content for broadcasting videos or sound or share content through social networks.
- **Personalization Cookies:** These are those that allow the User to access the service with some general characteristics predefined according to a series of criteria in the User's terminal such as the language, the type of browser through which accesses the service, the regional configuration from where you access the service, etc.
- **Analysis Cookies:** These are those that are well treated by us or by third parties, allow us to quantify the number of users and thus perform the measurement and statistical analysis of the use made by users of the service offered. To do this, your browsing on our website is analyzed in order to improve the supply of products or services that we offer.

Management of cookies and similar technology.

Users can configure the installation of cookies during the configuration process of the Website and are aware that disabling cookies and similar technology may affect the normal use of the Website and the services provided by the Website.

To disable cookies, Users should follow the instructions of each browser. For example:
